# Anti-Drug Abuse Council (ADAC) Performance Audit

DILG-DDB Joint Memorandum Circular No. 2018-01 dated May 21, 2018 with subject “Implementing Guidelines on the Functionality and Effectiveness of Local Anti-Drug Abuse Councils” was issued to provide the details and procedure for the implementation of the functionality audit for local anti-drug abuse councils in all local government units. The purpose of the conduct of the audit is to ensure the functionality and set the minimum standards for ADACs considering their critical role in the fight against illegal drugs and in the proper monitoring of drug-related incidents and personalities.

The BADAC Functionality Audit provides the standards and processes in monitoring and ensuring the compliance of the BADACs with the key functionality indicators. (DILG-MC 2018-135)
















